ePassport has been purpose built to complement the Children's University paper passport.

The three key criteria used when designing ePassport for students were;

Ease, fun and desire

For CU managers and schools, the key drivers were;

Ease and usefulness

We believe we have met both sets of criteria within ePassport and the feedback thus far has been very positive.

The students really liked being able to add in their activities and setup their avatars. The activity totals window showing the hours needed to achieve their next possible award was a real motivator, when it came to doing more activities.

From a management perspective the comprehensive yet easy to use reports provide a very easy way to manage and report on just how many hours students are spending on activities. This includes the ability to filter hours by individual students as a double check on their logging.

The rating of activities within the system is a very powerful mechanism as it provides feedback to what the students think of national, regional and local activities.

When entering the system all users are greeted with the home page showing the following information;

- Notice board** - national, regional and school news items
- Recent school activity** - details of school activity, most recent top
- Recent school images** - 'approved' images, most recent top
- My activity total** - hours logged, awards and hours until next award
- My recent activity** - recent activities

The two images on the right-hand side of the page can be used for advertising activities (internal / external) and can either be used to either generate revenue or to promote charitable firms.


This data can be viewed on screen or downloaded to a common separated file. The online filtering provides instant feedback and allows for a comprehensive way of dealing with information from one or many schools.

ePassport - Key benefits

There are many good reasons to use ePassport, here are just six;

1. the interface greatly enhances the Children's University experience for the student
2. the ability to share experiences and add images can boost the desire to do more activities
3. the reporting capability of the ePassport reduces the time needed to run a CU
4. the rating of activities and destinations gives a level of detail not previously obtainable
5. all the data regarding activities stored in one comprehensive system
6. quick and comprehensive feedback on the extra curriculum activities of those students in challenging circumstances

E-PASSPORT

Age range

ePassport is geared towards students from the age of 7 - 14, although there is no reason why this could not be used by students from the age of 5+.

Usage

ePassport is designed to be used alongside the paper passport. However, it is possible to use the system for both Children's University and for the tracking of extra curriculum activities for students who are not part of Children's University.

Loading data

ePassport includes options to load student (including existing hours), teacher, destination and activity data, from comma separated files. This allows a quick method to download information from your school system into ePassport.

Platform

From the school or students perspective you only need a internet browser to use the system. Compatible browsers are IE 7+, Firefox 3+ and Chrome.

Website and data

ePassport is hosted in a secure environment at Coventry and managed by Exasoft Plc. There is therefore no requirement by the school to manage this data.

Data protection

A key part of the system design is to safeguard student information which is why when setting up a CU or school, questions are asked to ensure data access is only given to authorised personnel. Where permission is not given, a CU manager will not see sensitive information like ethnicity, cared for, traveller, services child, special needs etc.

Payment

The system includes a variety of options for making payment, including Cheque, BACS, credit and debit card. For licences linked to the Children's University paper passports, these are approved by National CU before the order continues to payment.

Help & Support

Support is available from Children's University and Exasoft Plc (9am-5pm Mon-Fri, exc. Bank holidays and the period between Christmas and New Year).

This is a fully supported system and help is available on all aspects of the system.
